

**AFFIDAVIT FOR  
DISABLE PARKING AT METER**

---

**Pursuant to Administrative Order No. 99-58, paragraphs 3 and 13, respectively, the Clerk of the Court may administratively dismiss overtime parking citations issued against a disabled permit owner for the following reasons:**

Violation of 30-378(a) or 49(20)(a) [meter shows a violation] and 30-378(c) or 49(20)(c) [time on meter expired]

Meter parking complaints issued against vehicles displaying a "DV" license plate, a license plate stamped with the international wheelchair symbol, or a person issued a disabled permit, provided that the person in whose name such license plate or disabled permit is registered furnishes the Clerk's Office with a valid disabled parking permit registration, and an affidavit that he or she was operating the cited vehicle at the time the parking complaint was issued.

Violation of 30-378(b) or 49(20)(b) [meter restricts duration of time, officer indicates 4 hours or less]

Overtime parking tickets issued to an individual whose vehicle bears a valid disabled permit, upon presentation to the Clerk's Office a valid disabled parking permit registration and an affidavit by the permit owner that the citation was issued for parking at an on-street meter for 4 hours or less, and that the permit owner was present at the time of the alleged violation.

- a metered parking violation 30-378(a) or (c) or 30-49(20)(a) or (c) and I was operating the vehicle involved at the time the parking complaint was issued.

 an overtime parking violation of 30-378(b) or 30-49(20)(b), I was present at the time of the violation, and I was parked for 4 hours or less at an on-street meter and not longer than the maximum time permitted on the meter.

I have provided a copy of my valid disabled permit registration with this affidavit and a photocopy of my driver's license to the Clerk's Office for administrative dismissal of the parking citation noted herein.

**Pursuant to Florida Statute 92.525, under penalties of perjury, I declare that I have read the forgoing affidavit and the facts stated in it are true.**
